## SIGNING OF THE THREE SECTOR REFORM BILLS (RURAL ACCESS AND ROAD AUTHORITY, THE STATE ROAD FUND) OF EKITI RAAMP AND EKITI STATE WEALTH FUND BILL INTO LAW

## **PROTOCOLS:**

- 1. Today is a momentous occasion as we gather here to witness the signing of three significant sector reform bills into law. It is with great pleasure and a sense of fulfilment that I stand before you to inaugurate the Rural Access and Road Authority, the State Road Fund, both vital components of the Ekiti Rural Access and Agricultural Marketing Project (RAAMP) and the Ekiti State Wealth Fund Bill.

This dedicated fund will ensure that we have the necessary resources to carry out timely repairs, thus prolonging the lifespan of our roads and minimizing disruptions to transportation networks. We envision a state where our



roads are not only well-built but also well-maintained, ensuring smooth and safe travel for our citizens.

- 5. The Ekiti State Wealth Fund Law is our bold attempt to put in place the building blocks for sustainable growth and development. It is a combination of Infrastructure, future generations and Investment Fund to drive our shared prosperity agenda.

I would like to express my heartfelt appreciation to the Speaker, Principal Officers and members of the Ekiti State House of Assembly for their diligent efforts in reviewing and passing these reform bills. Your commitment to the welfare of our people and your tireless work in crafting legislation that reflects the needs and aspirations of Ekiti State is commendable.
- 7. I also extend my gratitude to the World Bank System especially the Country Director and his team for witnessing this historic occasion.
