Ekiti State Broadband Network Infrastructure requires a robust internet connection to facilitate various government activities such as data transfer, video conferencing, application services and accessing cloud-based services. The State is therefore desirous of a bandwidth subscription services that offer high reliability, low latency and sufficient capacity to meet our current and future needs.

The Bandwidth subscription services required is 700Mbps Upload and Download, with room for increase capacity and scalability. The Network Infrastructure required to deliver the bandwidth services must be Fiber Optic Cable Technology and Microwave technology as backup feeder lease line. Adequate security measures to be implemented to safeguard the network from cyber threats, including firewalls, protocols encryption and intrusion detection systems. Availability of technical support 24/7 and helpdesk support services.
