APPLICATION PROCESS AND GUIDELINES FOR OBTAINING BUILDING PERMIT IN EKITI STATE

Pursuant to Ekiti State Building Regulations, 2017, Part I, Schedule 2(3) any person intending to carry out any development on any land within the State shall apply to the Ministry/appropriate Area Urban and Regional Planning Office (AURPO) for appropriate advice/directives. In view of this, all individuals and organizations seeking to develop their land in Ekiti State can apply for a development (building) permit through the following process:
